Whereas as per the direction of the Hon'ble Jharkhand High Court vide judgment datrde 31.08.2023 passed in W.P.C. No. 1151/2020, direction was given to conduct the election of the executive body of Sri Rkss under the supervision of Hon'ble Mr. Justice N. N. Tiwari (Retd.), Administrator/VVM, (appointed by the Jharkhand High Court).

Accordingly, after appointment of the undersigned as Election Officer Scheduled was published on the notice board of the office situated in the premises of VVM and in addition of dated 28.09.2023 in the Prabhat Khabar newspaper. On the basis of the record prepared under the MoA of RKSS.

Clearly giving a details of the members in three categories (i) eligible members (ii) ineligible members (defaulter) (iii) and the members who died. The said notice was published in the notice board of office of the undersigned situated in the premises of VVM, www.vvmranchi.edu.in. and in the addition of the Prabhat Khabar daily newspaper on 28.09.2023.

And whereas, as directed by the Hon'ble High Court one opportunity was given to the defaulter members to deposit the subscription by or before on 06.10.2023.

And Whereas after lapse of the said period the account statement has been collected and verified and it has been found that only 19 defaulter members out of the list have individually deposited their membership subscription. On further verification it has been found that bulk payment in all a sum of Rs. 94,605/- as purported membership subscription of about 312 persons have been made in several tranches without any declaration and signature of the individual members which cannot be accepted as valid subscription of the persons mentioned in the several lists prepared under the signature of one Tushar kanti Sheet, in representative capacity.

However, if any individual member has paid contribution of membership subscription in the list submitted in bulk, he can submit receipt of deposit or individual declaration by way of affidavit regarding payment of his arrears of subscription by 11.10.2023 by 04: 00 P.M. so that the same may be accepted after verification of the name find mentioned in the lists of the ineligible (defaulter) members as earlier published if, individual declaration or production of receipt is wanting, the member will not be considered as eligible for participating in the A.G.M. Annual General Meeting and to cast their vote in the election of Executive body members, to be held on 29.10.2023, has already notified.
